PROJECT HISTORY AND FACTS

- Initial SR 26 Project Needs Report completed in 1999
- Public Workshops held in 2004, 2005 and 2006
- Final Environmental Document signed in 2008
- SR 26 Advance Intersection Improvements completed at Central Avenue in 2005
- SR 26 Detour Routes Project constructed between 2010 and 2013 and is substantially complete
- SR 26 Mainline aerial utility relocations began in Fall 2012
- Land acquired from approx. 250 parcels along SR 26 Project limits

PROJECT DETAILS

- Provide a continuous shared center turn lane that becomes a dedicated left turn lane at all Intersections
- Overall project is 4.14 miles in length
- Right turn lanes provided at most intersections
- Closed drainage with curb and sidewalk between Assawoman Canal to Windmill Road (2 miles)
- Open drainage without sidewalk between Windmill Road and Clarksville
- 5' shoulder/bikeway throughout Project limits
- Underground utility relocations and Improvements will be constructed at the same time as roadway improvements
- Re-construction of five signals which will be linked together for better coordination
- Pedestrian accommodations at signalized intersections
- Re-construction of 237 entrances to provide safer entrances/exits from the roadway
- Four stormwater management ponds will be constructed
- Replacing two bridges (culverts) on SR 26 crossing Whites Creek
- Will be maintaining pedestrian traffic during construction.
- All improvements will be constructed to ADA standards

SCHEDULE DETAILS (Schedule is weather dependent)

- Roadway construction will begin late 2013
- Substantial completion anticipated summer/fall 2016
- Stronger Lane Closure Restrictions during Peak Season (May 15 – Sept 30) vs. Off Peak Season

CONSTRUCTION EXPECTATIONS

- Night work is allowed, but is **NOT** Mandatory
- Work will be in the same location multiple times (utility work, drainage work, roadway construction, final paving)
- Work will be in multiple locations at the same time (Ocean View, Millville and Clarksville)
