1. An original subcontract agreement for each DBE participating on the project that includes the following:
 - Addresses all pertinent provisions and requirements of the prime contract.
 - Includes a description of the work to be performed by the DBE subcontractor.
 - Specifies the dollar value of each item of work to be completed by the DBE subcontractor and the bid price of each item of work to be completed by the DBE subcontractor.
 - An attached copy of the most current FHWA 1273- Required Contract Provisions Federal-Aid Construction Contracts.
 - Assurance that retainage will not be withheld unless the prime contract with DelDOT allows for the withholding of retainage.
 - Assurance that payment of all funds received from DelDOT for work performed by the subcontractor will be paid in accordance with prompt payment regulations outlined in 49 CFR §26.29.
2. A copy of each subcontractor's Delaware Business License.
3. A Regular Dealer Verification Form if applicable.
