



# DelDOT – Development Coordination

## Critical Items for Acceptance

### Traffic Count Submission

*\*Please Note: All items below are required. Submissions not including these requirements will be declined.*

1. Traffic Impact Study (TIS) or Traffic Operational Analysis (TOA) Scoping Memo shall be accepted by the applicant and submitted with the Traffic Counts submission received by DelDOT within 1 year of the Scoping Memo issuance. (Appendix C)
2. Project narrative including the following:
  - a. Description of existing and proposed uses of the site
  - b. Land use code(s) using the latest version of the ITE Trip Generation Manual
  - c. Seasonal Adjustment Factors table (consistent within those provided within the Scoping Meeting Memo)
3. Preliminary site plan depicting existing and proposed entrance locations. (Figure 1A)
4. Continuous flow diagrams depicting existing intersection traffic control, raw/seasonally adjusted/balanced (if applicable) existing peak-hour traffic volumes through the study area, and the peak hour identified for each intersection. Diagrams must be continuous; individual intersection diagrams will not be accepted. (Figures 2–4A)
5. Manual and Automatic Traffic Recorder (ATR) peak hour turning movement counts shall meet the requirements in DCM Section 2.2.8.5.C and include the following items (Appendix A):
  - a. Manual turning movement counts shall be provided for one (1) full day and ATR counts shall be provided for one week. If the manual count volumes differ by more than ten percent (10%) from the ATR volumes for the same time periods on any approach on that day, an engineering justification shall be provided.
  - b. Turning movement counts should be submitted in Excel or PDF format.
  - c. Description of conditions present at time of count collection (weather conditions, accidents, or traffic detours, holidays, and special events).
6. Proposed trip distributions for all committed developments outlined within the Scoping Memo. (Appendix B)
7. Correspondence from DelDOT or Local Land Use Agency (LLUA), if applicable. (Appendix C)
