




KSIP I Piccard LLC (Rounds 3/6/8) Extension and Progress Payments Request


- Project Description: 890,348 square feet of industrial warehousing/logistics; site construction is underway; site is being actively marketed however no identified tenants or leases
 - Approved in Round 3 for an award of \$2.5 million with 90 jobs
 - Original TIIF Agreement dated November 2021;
 - Site sold in December 2021;
 - ▶ Reassignment of TIIF grant approved in Round 6, new TIIF Agreement dated March 24, 2023, standard three-year term
 - Received TIIF funding increase of \$2,900,855.00 in Round 8 July 2023, TIIF First Amendment dated August 31, 2023, conditioned on having a tenant within one year
 - Recent project delays due to water line relocation and FAA approval of existing easements granted by New Castle County to the former owner (Churchmans 273 LLC) have stalled the completion of the improvements
- TIIF Scope of Work:
 - Construct new Piccard Road connector between Old Churchmans and Churchmans Roads, with signal and ped crossings
 - Churchmans Road and Old Churchmans Road improvements
 - Channelized left turn lane on southbound US 13 at DE 273
 - Shared-use path along frontages, new transit stops
 - Water line relocation due to widening on Churchmans Road
 - Associated power pole relocations in right-of-way
- Employment Standard: 225 (potential) New Jobs in Year 3 (NO CHANGE FROM PREVIOUS ROUND)
- Public Endorser: Charuni Patibanda, Director, NCC Office of Economic Development





TIIF All Rounds Awards Comparison




















- Project Description: A 32,000 sq. ft. professional medical office building to be occupied by Beebe Medical as a primary care facility and a family medicine residency facility with residency teaching space.
 - ➤ Site is surrounded by areas that fall 90th to 100th percentile for Population Over Age 64, and within 2 miles from areas of 90th to 95th percentile for Unemployment Rate indices, per EPA's Environmental Justice Mapping Tool.
 - ▶ Site is located within a Level 2 State Strategies Investment Area.
- ► TIIF Scope of Work:
 - ► Full movement site entrance modifications, widening and restriping of Long Neck Road to create a protected left turn lane and right turn lane into the site entrance, sidewalk across frontage, bus shelter pad.
 - ► Engineering design, construction contingency.
- ► Employment Standard: 20 new jobs created plus 24 jobs maintained in Year 3
- ▶ Public Endorser: Sen. Brian Pettyjohn, SD 19



- Financial Stability: No items of concern; validly organized and in good standing; no compliance issues with other state agencies, no major labor law violations

Summary of TIIF Program Improvements Employment Standard Guidelines Adopted by Council 7/26/23

TIIF Employment Standard Guidelines

In an effort to align Delaware's economic development grants, the TIIF Council (Council) is seeking to adopt guidelines that define the employment standard based on Delaware Code and Administrative Code.

Definitions

For purposes of TIIF, the "significant number of direct, permanent, quality, full-time jobs" definition shall utilize the following guidelines supported by the Division of Small Business:

Significant Number

- A TIIF funding-to-jobs ratio that indicates a beneficial investment of public funds
- The jobs creation number stated in the application should be achievable within 3 years of the development project's completion

Direct

• Jobs are not provided through a staffing agency or 1099 contractor

Permanent

- Not seasonal
- Not term (as in an X-year contract)
- Part-time employees may not be aggregated to equal full-time employees

Quality

- Employee annual compensation must exceed \$35,000 annually (salary or hourly)
- Employer-offered health benefits

Full Time

• Employee compensation is based on a work week of at least thirty-five (35) hours

Generally Excluded Development Types

While the Council acknowledges that all new and expanding businesses in the state in some measure add to the economic prosperity of the state, the following development types are generally considered to be excluded from consideration for TIIF based on the adopted jobs definitions:

- Projects which do not attract or retain employment opportunities
- Restaurants, for-profit retail, convenience stores, gas stations, hospitality, residential, mixed-use projects that incorporate one or more of these categories

Lower Priority Development Types

For purposes of considering applications, the following development types are lower priority based on jobs creation and jobs certainty:

- Private speculative real estate ventures
- Projects where there are no identified tenants at the time of application
- Projects which do not create a significant number of direct, permanent, quality, full-time jobs

Notwithstanding the foregoing, the Council reserves the right to consider funding, including partial funding, requests based upon jobs creation and public benefit factors.
