### Contract No. T201769009; Double Bridges Road Multi-Use Trail – Phase 1

#### **Project Description**

Design and construction of a 10' wide multi-use trail facility along Double Bridges Road from Muddy Neck Road to Parker House Road. Project will be split into two phases. Phase 1 is moving forward will go from Muddy Neck Road to Neptune Drive. Phase 2 will be from Neptune Drive to Parker House Road and will be programmed later.

### Contract No. T202401201; MLK Boulevard/South Little Creek Road Bicycle and Pedestrian Connector

#### **Project Description**

Development of a Shared Use Pathway on the south side of S. Little Creek Road from Horsepond Road to Babb Drive. Proposes ADA, Drainage, and other improvements, as necessary. Addition of curb at some locations and construction of pedestrian median crossing islands.

#### **Project Schedule (Revised due to delays with federal freeze)**

PS&E Submittal scheduled Fall 2027

#### **Project Notes**

Project has expended all Preliminary Engineering (PE) funds. DelDOT is funding the remaining PE work with FY25 Carbon Reduction Funds, which will begin again once the funding request for this work moves forward in the new state fiscal year. FHWA Division Office reached out to the project manager on 6/26/25 with the revised RAISE Grant Agreement Template, which was revised in accordance with recent Executive Orders. DelDOT is working with FHWA to continue to move the draft RAISE Grant Project Agreement forward towards execution, under the impression that they will execute an agreement for the previously awarded construction funding (\$12.25M) and project scope.

### Contract No. TBD; Coastal Highway Intersection Improvements

#### **Project Description**

Due to the bicycle accidents at the Kings Highway/SR 1 intersection, this project will be reconfiguring the SR 1 NB right turn lane, which is anticipated to encourage the SR 1 NB right tuning vehicles to reduce their speed to nearly a stop to comfortably make the turn onto Kings Highway. This should enhance the safety and awareness between vehicles turning onto Kings Highway and the high-volume bicyclists crossing the intersection.
