TRANSIT VEHICLE EXPANSION**PROJECT SCOPE/DESCRIPTION:**

Paratransit Buses – Purchase two buses in FY 2008 – 2010. Requirements are based upon current rate of growth anticipated by the Delaware Transit Corporation (DTC) service plan.



Support Vehicles – This project also included the prior year purchase of street supervision vehicles to support expanded vehicle fleet.

PROJECT JUSTIFICATION: The previous period investment in transit vehicle expansion was necessary to meet projected transit service demand based on census information. The future purchases are based on the anticipated paratransit demand.

TRANSIT VEHICLE REPLACEMENT AND REFURBISHMENT

PROJECT SCOPE/DESCRIPTION: This project contains:

30' Low Floor Buses - Purchase four low floor buses in FY 2004 and eight buses in FY 2007.

5310 Vans for Elderly and Handicapped Program – Program provide funds for organizations to provide transportation for the elderly and disabled in Kent County.

Paratransit Buses - Purchase eight buses in FY 2004, five buses in FY 2005, 16 buses in FY 2006, 13 buses in FY 2007, and 28 buses in FY 2008 – 2010 to be used in accordance with the DelDOT/DTC approved service plan and supporting vehicle replacement schedules.

Support Vehicles – Purchase maintenance related vehicles to be used in accordance with the DelDOT/DTC approved vehicle replacement schedule totaling two vehicles in FY 2005, seven vehicles in FY 2006, and one vehicle in FY 2007.
