TRUCK WEIGHT ENFORCEMENT

PROJECT SCOPE/DESCRIPTION: Funding was provided in the FY 2003 Bond Bill to implement a program to provide facilities for truck weight enforcement. One specific site has been identified on US301 northbound for truck traffic before the Maryland state line. A second site is being considered between US 13 and SR 1 for northbound SR 1 traffic and possibly for southbound US 13 truck traffic.

PROJECT JUSTIFICATION: These sites will enhance safety and increase compliance with federal enforcement regulations.
