#### 9. OTHER NOTES OR OBSERVATIONS:

At the rear of the cleared lot is a one story side gable wood frame shed that was only partially visible from the right-of-way. Aerial photographs suggest that the shed was standing on the property by the 1990s; however, it is unclear if the shed was built prior to 1965.

The property is also being evaluated or reassessed for its National Register eligibility or listing status. This evaluation assessment is triggered by the federal undertaking initiated by DelDOT and the Federal Highway Administration as part of the SR 1 Roth Bridge to Interstate 95, Capacity Improvement Project (T200511001; Federal Aid NH-N067(26)). 
