

Project Status Updates

MILFORD AREA

No progress has been made in the Milford Area since July 2007 and no work is currently underway.

ELLENDALE AREA

The Ellendale Area Environmental Assessment (EA) was approved by the FHWA on September 28, 2010 with a Finding of No Significant Impact (FONSI) on the natural and human environment. The issuance of a FONSI by FHWA concludes the environmental process for the Ellendale Area. Elements of the On-Alignment alternative will transition through the design process as funding becomes available.

GEORGETOWN AREA

DelDOT has identified the Refined On-alignment alternative as the Preferred Alternative for the Georgetown Area. The Georgetown Area Environmental Assessment (EA) was completed in 2012.

DAGSBORO

DelDOT has identified the Blue Alternative as the Recommended Preferred Alternative for the Millsboro-South Area. The Millsboro-South Area DEIS was published in August 2013 and is now available for public review and comment until October 4, 2013.

MILLSBORO-SOUTH AREA

Area Projects

The Delaware Department of Transportation Statewide Improvement Program (STIP) is the state's sixyear Capital Transportation Plan (CTP). The first four years of the program (2013-2016), represent the fiscally constrained state and federal program approved by the Federal Highway Administration (FHWA) and the Federal Transit Administration.

This area was identified as a high priority by Sussex County Council due to high development growth in the corridor over the last several years. This project was completed in Summer 2012 and is open to traffic.
14	Patriots Way (S318), Avenue of Honor to Stockley Branch	Patriots Way	This area was identified as a high priority by Sussex County Council due to high development growth in the corridor over the last several years and came from the SR 24 Mainline Planning Study.
