Online Informational Meeting: Bridge 3-714 on New Road over Canary Creek

Tuesday, June 30 @ 3:30 p.m.

The Delaware Department of Transportation (DelDOT) would like to invite residents and all other interested parties to a virtual informational meeting regarding the replacement of Bridge 3-714 on New Road. The purpose of the meeting is to present the findings of a recently completed hydraulic study. The hydraulic study was performed to determine a proposed bridge replacement size and proposed roadway elevation that would assist in reducing localized flooding.

Westbound Route 9 Traffic Improvements Completed





Traffic improvements to one of the more challenging intersections in the Five Points area were completed in late May.

One of the Five Points Working Group's recommendations, C-9, was to "evaluate potential short-term safety and operational improvements at Route 9, Plantation Road, and Beaver Dam Road while longer-term improvements are under development." Westbound Route 9 has been restriped to provide two continuous lanes between Route 1 and the connector to Plantation Road and Beaver Dam Road. This new arrangement provides clearer guidance to drivers about what lanes to use. Furthermore, a new sign was installed on northbound Route 1 approaching Five Points to help drivers choose the correct left turn lane to reach their destinations.

Phase 1 of the Plantation Road improvement project, currently under design, will provide even more significant enhancements in this area. Construction is scheduled to begin in early 2022.

Georgetown to Lewes Trail Extended

DelDOT has completed an extension of the Georgetown to Lewes Trail in the area between Cool Spring Road and Log Cabin Hill Road. This extension adds about 4,000 feet of 10-foot-wide paved trail from where it previously ended at Log Cabin Hill Road. This addition results in a continuous trail of about seven miles all the way to Gills Neck Road! The project includes bike racks and an informational kiosk and creates a low stress setting that is restricted to nonmotorized use. Traffic signs have been installed to alert both trail users and drivers of intersections where the trail crosses roadways.



Strategic Highway Safety Plan Workshop Underway



DelDOT is currently updating the agency's Strategic Highway Safety Plan, a vital component of making Delaware's transportation system safer. The Virtual Public Workshop for the 2020 Delaware Strategic Highway Safety Plan is now live and can be accessed at

https://deldot.gov/Programs/DSHSP/vw/ until July 7, 2020.

The Virtual Public Workshop includes a presentation outlining the Strategic Highway Safety Plan process showing current crash data trends and the plan's proposed Emphasis Areas.

The workshop also encourages those interested to **complete a short survey in order to provide** valuable feedback to the Core Team. Within the survey, those interested in doing so are given the opportunity to sign up for one or more Emphasis Area Teams which will help develop specific strategies to improve safety on Delaware's roadways in conjunction with the final adopted Plan.

Bicycle Safety

Bicycling is both an important part of Delaware's beach culture and a practical mode of transportation. In Delaware, as in all other states, cyclists have the same rights and duties as motorists. This means that cyclists are allowed on the road throughout the beach area. When driving, yield to cyclists as you would to other motorists.

When you see a bicyclist on the road, remember that s/he is traveling without the benefit of the seat belt, air bags, crumple zones, and increased visibility that drivers enjoy. So be cautious and obey Delaware's law requiring three feet of separation between your vehicle and any bicyclist when passing or overtaking. And remember that cyclists can have widely varying levels of experience and ability – even more so than motorists. Be especially careful at intersections and driveways to avoid cutting off cyclists and pedestrians.

Bicyclists, as equal users of the road, also have responsibilities. When riding, ride as predictably as possible. Stay to the right as much as you can. Be alert and anticipate potential conflicts. Be courteous to pedestrians as well, especially when riding on trails or crossing sidewalks or crosswalks. And remember that cyclists under 18 are required to wear helmets, and it's a good idea for everyone!
