



## Construction Information Meeting for Section 1 South of Boyd's Corner Road to South of SR 1 April 20, 2016

The meeting commenced at 10:05AM with Ken Cimino from DelDOT welcoming all in attendance on behalf of the Delaware Department of Transportation and the US 301 Mainline Project Team.

Ken Cimino then introduced himself and asked each of the US 301 Project Team members to introduce their selves and also give a brief description of what they do.

Ken Cimino from DelDOT turned the presentation over to representatives from Tutor Perini working on the Section 1A Contract to give an update on recent and future construction activities.

Joe Hockersmith, Damon Petrino and Dan Myers began by telling the group that Tutor Perini had implemented the detour of Jamison Corner Road earlier this month. The detour will be in effect until late December of this year. Construction Crews are continuing with the installation of Erosion and Sediment Controls from the Scott Run to Boyds Corner Road.

Construction Crews have begun driving piles for the Jamison Corner Road Bridge and haul borrow for fill dirt.

Tutor Perini representatives informed the group that future construction activities through the month of June would include the completion of topsoil stripping, construction of the temporary crossing at Scott Run, construction of the bridges at Jamison Corner Road and Scott Run, utility work for sewer and electric and hauling dirt from the borrow pit.

Ken Cimino thanked the representatives from Tutor Perini for their presentation and turned the presentation over to Dan Orr from R.E. Pierson to update the group on the progress on the Section 1C Contract.

Dan Orr began by informing the group that R.E. Pierson has mobilized to the site and set up their construction field offices. Crews continue with the installation of Erosion and Sediment Controls including excavating for Sediment Ponds and Basins and stripping topsoil along the alignment.

Mr. Orr informed the group that future construction activities through the month of June would include the completion of topsoil stripping and the start of embankment activities.

Ken Cimino from DelDOT thanked Dan for his presentation and continued the meeting by asking Tutor Perini and R.E. Pierson representatives to update the group on their plans for night time construction activities.

Joe Hockersmith from Tutor Perini informed the group that there will be minimal night time construction activity. These activities are expected to include the setting of steel girders and deck pours for the bridges. It is anticipated that Tutor Perini will commence concrete paving for the new roadway in July of 2017.

Dan Orr from R.E. Pierson informed the group that that they did not anticipate any night time construction activities at this time.

Javier Torrijos from DelDOT informed the group that the Department has asked for Noise Waivers from the Town of Middletown and New Castle County on behalf of the contractors.

Ken Cimino informed the group that a meeting to discuss night shift operations for Section 1 Construction was scheduled for 7:00PM tonight at the Middletown Town Hall.

Ken Cimino from DelDOT updated the group on the Departments Community/Public outreach efforts. The DelDOT Project Team has had meetings with St. Georges Technical High School and discussions with the Appoquinimink and Colonial School Districts regarding the closure of Jamison Corner Road.

Ken Cimino met with all of the local Fire Departments earlier this month to discuss Emergency Services for the community during the closure of Jamison Corner Road.

Ken Cimino asked the group if everyone had signed in prior to the meeting. Residents will receive updates directly from Ken by completing the email address portion of the sign in sheet. Ken also advised the group that his business cards were on the table next to the sign in sheets and that they could email or telephone him at any time should they have questions or concerns regarding the project.

Ken Cimino opened the floor for discussion.

Bob Hershey from the Appoquinimink School District asked about the Bunker Hill Run around Road.

Ken Cimino replied that the Bunker Hill Temporary Road was part of the Section 2A Contract and that he would discuss it with him after this meeting. Information about the Section 2A contract will be presented next Wednesday, April 27, 2016.

A resident asked if additional signage for the Airmont Drive Closure could be installed on Hyetts Corner Road.

Ken Cimino responded that the Project Team was working to improve the signage.

A resident had a question about where the new road was going.

Ruby Dillmore, Representing New Castle County Councilman William Powers, asked if the Noise Waivers had been approved.

Javier Torrijos responded that the waiver was submitted on April 4, 2016 and as of this date it hadn't been approved.

Ms. Dillmore asked if the Department anticipated any problems in getting the waiver granted.

Mr. Torrijos responded that the Department didn't anticipate any problems with the approval process.
