Purpose Of Workshop: Discuss And Listen


The purpose of this informal workshop is to continue the effort to refine and evaluate alternatives and eventually select a Preferred Alternative for an improved US 301 from the Maryland Line to SR 1, south of the C & D Canal.

These workshops are your opportunity to discuss and comment on the Alternatives Retained for Detailed Evaluation. We encourage and welcome your comments on the displayed material, such as:

- Retaining the toll free ramps to the SR 1 bridge over the C&D Canal
- Spur Road, Armstrong Corner Road Area to Summit Bridge
- ▶ Interchange Options south of Summit Bridge (SR 15 / SR 896)
- Interchange Options in the Armstrong Corner Road Area
- Alignment Options in the Boyds Corner Road Area

Your comments, along with those of the federal and state environmental resource and regulatory agencies, state and local elected officials and the results of the continuing evaluation by the Project Team will be considered by DelDOT in reaching an informed decision on a preferred alternative.
