The Delaware Department of Transportation (DelDOT) announces the second round of Public Workshops for the US 301 Project Development initiative. The workshops will be held on Monday, September 12 and Tuesday, September 13, 2005 from 4:00 PM to 7:00 PM at the Middletown Fire Hall and on Monday, September 19, 2005 from 4:00 PM to 7:00 PM at the Townsend Fire Hall. The public is encouraged to attend the open-house format workshops on any of the three days, anytime between 4:00PM and 7:00PM.

The Range of Alternatives (potential solutions) and an assessment of each alternative's effects will be presented. This information will be used to assist in the preparation of the Environmental Impact Statement (EIS) for the project. Members of DelDOT's Project Team will be on hand to listen to your ideas and answer your questions.

Interested persons are also invited to express their views in writing, giving reasons for support of, or opposition to; 1.) the alternatives being presented and the assessment of their effects and 2.) the Project Team's recommendations regarding alternatives suggested to be retained for detailed evaluation, the next step in the project development process. Comments received from the public, along with those from the federal and state environmental resource and regulatory agencies will be considered by DelDOT in reaching an informed decision on which Alternatives should be retained for detailed evaluation. Comments will be received during the workshops or can be mailed to DelDOT Public Relations, PO Box 778, Dover, Delaware 19903. Written comments should be submitted prior to October 14, 2005. Workshop information will also be posted on-line shortly after the workshop on the project web site www.US301.org.
